

## Southwest® Rapid Rewards® Sweepstakes (“Sweepstakes”)

### Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID IN ALASKA, PUERTO RICO, RHODE ISLAND AND WHERE PROHIBITED OR RESTRICTED BY LAW. MUST BE PRESENT TO WIN.

1. **Eligibility:** Sweepstakes is open to all legal residents of the fifty (50) United States and the District of Columbia (excluding Alaska and Rhode Island) who are 18 years of age or older and have a valid Southwest Airlines Rapid Rewards® account at the time of entry. It is free to enroll in Rapid Rewards (to enroll, visit [www.southwest.com/enroll](http://www.southwest.com/enroll)). Rapid Rewards accounts are subject to its Rules & Regulations. Employees of Southwest Airlines Co. (“Sponsor”), Infinite Agency (“Administrator”), Petco Park, their advertising and promotions agencies, and their immediate families (spouse and parents, children and siblings and their spouses) and individuals living in the same households of such employees are ineligible. Eligibility is contingent on agreement to, and compliance with, these Official Rules and Sponsor’s decisions, which are final and binding in all matters related to the Sweepstakes. To enter the Sweepstakes, Participants (as defined below) must complete an entry form provided at the Southwest Airlines® activation location at Party in the Park at Gallagher Square, 110 Park Blvd, San Diego, CA 92102 (“Event”) or enter via the QR Code, accessible throughout the Event. All entries become property of the Sponsor and will not be acknowledged or returned. Incomplete entries are not eligible. Individuals who do not follow all of the instructions, provide the required information in their registration, and/or abide by these Official Rules or other instructions of Sponsor may be disqualified. Entries must be received by 6:20 PM PT on their respective dates. Entries limited to one (1) per person. Sponsor’s clock is the official timekeeping device for this Sweepstakes.

No photocopied, mechanically, or electronically reproduced entries accepted. Any attempt by any person found to enter or in any way attempt to obtain more than the authorized number of entries will be found to be ineligible, and their entries will be disqualified. Any eligible individual participating in this Sweepstakes shall be a “Participant.” Participation must be by the Participant. In the event of a dispute as to the identity of a Participant, the authorized account holder of the Rapid Rewards account used to enter the Sweepstakes will be deemed to be the Participant. Potential winners may be required to show proof of being the authorized Rapid Rewards account holder. If the identity of the individual who actually participated in the Sweepstakes cannot be resolved to Sponsor’s satisfaction, the affected individual’s entry will be deemed ineligible.

Participants are required to provide truthful information and Sponsor will reject and delete any entry that it discovers to be false or fraudulent. Sponsor will disqualify any entry from individuals who do not meet the eligibility requirements.

**3. Drawing:** Immediately following the Sweepstakes Period, a random drawing from all eligible entries received will be conducted by Sponsor at the Event. Sponsor will notify potential winner by phone immediately following the drawing, and potential winner must answer the phone. Sponsor will not leave a message or make an additional call. Potential winner must be present at the Event and be present at the Southwest Airlines activation location within fifteen (15) minutes of Sponsor’s phone call. Upon validation, potential winner must execute and return the Required Documentation (as defined below). Odds of winning will depend on the total number of eligible entries received. Participants must be present to win. All potential winners are subject to eligibility verification by Sponsor, whose decisions are final and binding. **4. Prize:** There will be two (2) prizes awarded. Each prize consists of one (1) card redeemable for 40,000 of Southwest Airlines Rapid Rewards bonus points (subject to Rapid Rewards Restrictions set forth below). Approximate retail value (“ARV”) of each prize is \$480. ARV of all prizes is \$960. Winner is responsible for any additional costs needed to reach their destination if the Rapid Rewards points do not cover the entire cost of the flight.

**5. To Claim Prize:** Potential winner will be notified by phone and must be present at the Southwest Airlines activation location within fifteen (15) minutes of Sponsor's phone call. Potential winner will be required to complete and sign an Affidavit of Eligibility and Liability Release and, where legal, a Publicity Release (collectively, the "Required Documentation"). The Required Documentation will be provided onsite. If a potential winner cannot be contacted at the phone number provided on the entry form; if a potential winner is not present at the Southwest Airlines activation location within fifteen (15) minutes of Sponsor's call; if Sponsor is unable to verify potential winner's eligibility; if potential winner fails to sign and return the Required Documentation or fails to comply with these Official Rules; if a potential winner is unable or unwilling to accept the prize as stated; or if the potential winner cannot be verified as eligible for any other reason, the potential winner is disqualified and a new potential winner will be selected by random drawing from among the eligible entries. In the event that a potential winner is disqualified for any reason, the next received and eligible entry received by Sponsor

Sponsor will identify each potential winner and verify the potential winner's eligibility at the Event. Once Sponsor has verified potential winner's eligibility, winner will be asked to be captured on video and featured on the Petco Park Jumbotron ("Jumbotron"). Winner is not required to appear on the Jumbotron in order to claim the prize.

**6. Conditions:** Payments of all applicable federal, state, and local taxes are solely the responsibility of the winner.

By participating in the Sweepstakes, winner agrees to have his/her name, voice, likeness, photograph, statements, opinions, biographical information and/or Sweepstakes entry used in any advertising or broadcasting material, whether relating to this Sweepstakes or otherwise, in any media, worldwide, now known or hereinafter developed, in perpetuity, without additional notice, payment, or other compensation unless prohibited by law.

Any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including associated with entering this Sweepstakes, but in no event attorneys fees.
